# **Trustee Manifestos**

There are five nominations for the position of trustee. This is not a competitive election as there are sufficient vacant positions for all to be elected as trustees. The five candidates are listed below, along with their manifesto. Full members will be able to vote FOR or AGAINST these candidates at the AGM.

## Matthew Tennant

Existing Trustee seeking re-election.

## Proposed by Mark House and seconded by Andrew Birchall

I am seeking the support of OutdoorLads members to re-elect me as a Trustee of the charity. It has been a privilege to have been appointed to the board over the last six years, and more recently to serve as chair Vice-Chair in the last three where I've managed our wonderful staff team. Throughout my tenure, the board has faced challenging situations and made decisions that ensure our charity's future. We've also achieved huge successes with the launch of our new website, growth in member and leader numbers, and the vibrant range of events available for our members to attend.

Should I be successful in my re-election campaign, it is my intention to seek the Chair of the Trustee Board, where I will strive to ensure OutdoorLads remains the leading LGBT outdoors charity in the UK.

My priorities for the next 3 years:

1.) Set our strategy for the next 3-5 years. There are some key questions the charity needs to consider: How do we future proof the finances of the group in the long run? Is our event programme still relevant and interesting to members? What are the key threats to the group in the short to medium and long term, are there any opportunities we are missing? Within the next year I would like the board, in consultation with our leaders, coordinators and members, to set out what our strategic priorities are going to be for the forthcoming years and for board to then focus on how to resource them.



- 2.) Support and grow our volunteer leader base. Our volunteer leaders are at the core of what OutdoorLads is about and without them we cannot run as a charity. I want to ensure that we have an easy and flexible application process to encourage more members to come forward as leaders. I also want to ensure our current leaders have the resources, whether that is a larger training budget or more office support, to continue leading a range of great events.
- 3.) Membership drive to continue the growth of new members and retention of current. For several years now our membership has remained relatively static ranging between 1900 and 2000 people. There are two areas we need to focus on. Firstly, growing the numbers of new paid members to the group by a range of new and creative initiatives, such as breaking into the outdoor sports and team-based events market. Secondly, reducing the member of members who do not seek to renew their membership. My intention is for the Trustee Board to thoroughly review and analyse retention metrics, improve feedback from outgoing members, and seek to put in place policies to reduce membership cancelations.
