AGM/23/01 Welcome & Housekeeping

Joey Payne welcomed all those in attendance (both in the room and online) and confirmed numbers exceeded the required quorum of 100 to conduct the business of the group. He discussed the shared values of OutdoorLads, the positive feedback received from the annual survey, activities and BIG events that had taken place, and fantastic partnerships that have helped with exposure and supporting the future of the organization. JP also summarized the agenda for the meeting today.

AGM/23/04 Financial Overview to 31 March 2023 & Current Financial Year

Treasurer Jake Higgins presented this section. He explained that OutdoorLads had generated a surplus for the year ending 31st March 2023 organically through events and income from the ODL bar; and that the current financial year was also showing a surplus so far despite increased costs. He felt assured that the financial security of the group was looking positive with a healthy balance in the bank and exceeding reserves. He believes there are now the funds to be able to invest in the future and expects growth to continue for years to come.

Question: Are there any plans for the cash surplus to support members in

this current cost of living crisis?

Answer: **JP** Yes – we have the OutdoorLads foundation to help support

with this but it is massively underutilised. It is there if ANY member is struggling and wants help with either the cost of an event or even the means to get to the event (travel costs.) There is a simple form to submit your request, it is very discreet and only the staff members processing the request will

discreet and only the staff members processing the request wi see it. Please make use of it if it gets you on an event you might otherwise have missed, this is why we are a charity.

Question: The accounts show IT website costs of £46k – why is this?

Answer: **LR** The previous year showed costs of only £802 - this is

because the website was under contract but was not being updated or maintained properly; we therefore changed provider with the new company needing to undertake vital upgrades. The accounts therefore show this high figure but the

spend will settle from next year.

AGM/23/05 Resignation of current Board of Trustees Statement

Joey explained the position of the current Board of Trustees. They had wanted more involvement from the members and hence over the last two years had established sub-committees to enable members to have more control. The 30 members on these sub-committees have provided extra manpower to get things done, and hence the bigger board may now not be as necessary as before, therefore it was agreed that all would resign or not stand for re-election at this meeting, having achieved what they set out to do. The exception is the current treasurer Jake Higgins, who had been co-opted to the board in June 2023 and would stand to be elected by the membership today. It was confirmed that Jake went through a lengthy interview process earlier in the year including an application and interview.

AGM/23/06 Appointment Interim Board & Trustee

Three individuals, all who have been Trustees previously, had put themselves forward for election to an interim Board which will oversee the development of a new structure for the future Board and undertake the recruitment process of new trustees, in order to secure the future of OutdoorLads:

David Lawrence (appeared via video) is currently a walk, hostel & camping leader. He was previously a Trustee for six years and Chair for two of those; his wish is to keep the core values of the group going and to protect its future.

Neil Sharp (appeared via video) has been a member of OutdoorLads for 14 years, he is a leader and organiser for the South-East, as well as a previous Trustee for four years looking after leaders & volunteers. He wants to help recruit the new board that will in turn support all regional co-ordinators, organisers and leaders across the UK ensuring the continued focus on their development and growth.

Peter Walter (present at venue) has been a member for 16 years and today will be his 300th event! He served as a Trustee for 8 years, three as Chair and

five as Vice-Chair. He would like to work quickly to come up with a structure for the new board in light of the current board stepping down, and hopes to run an open recruitment process, with an General Meeting called ASAP for the members to approve the new appointments. The interim board will step down at that point.)

Question: Why will members not be included in the consultation process

for appointing a new board?

Answer: **PW** Because although the board affects the long-term future of

the group it does not necessarily affect its members directly. BUT any members will be heard and can contact us directly.

Question: From your answer there is a disparity with why we are here as

a group. Surely the members should lead the way forward in

choosing a new board? (Danny Ballantyne)

Answer: **PW** I am not opposed to a wider consultation with the

members but I am unsure if we could make it work. We will undertake a member survey and the new board will be steered by the members views. What would the members like to see?

Question: Just an observation but surely a new board would have to be

officially voted in by the members anyway after being co-

opted?

Answer: **PW** Exactly, we just want to make it happen. This is a short

term project to agree what we want from a future board and to

get them in place quickly.

Question: How do the sub-committees fit in? Will there be much

interaction between the sub-committees and the Interim

Board?

Answer: The single focus is for getting the future board in place and I

don't think there will be much involvement with the sub-

committees.

It was confirmed that treasurer and co-opted board member Jake Higgins has put himself forward officially for the role as Treasurer. He was co-opted in June following a lengthy recruitment process; he is an accountant working in audit and wants to focus on the financial stability and growth of OutdoorLads.

Further Questions before the votes were in:

Question: Have the charity commission been involved for advice?

Answer: **JP** Yes, they have been consulted and checked with multiple

times.

Question: Do the interim board believe OutdoorLads should be open to

women?

Answer: **PW** Anyone who shares our vision and values and loves the

outdoors is welcome on any OutdoorLads event, but in terms of the long-term strategy that is for the future board to decide.

Question: What is the reason for the board resignation?

Answer: **JP** That was covered previously in the meeting and in the

statement sent out a week ago. Having achieved what it wanted to do, it is now sensible for the current board to stand

down and for the charity to move on.

AGM/23/07 Highlights of 2022/2023

Joey Payne focused on the highlights of the year – he again mentioned the surplus making it possible to invest back in the groups Foundation; the large number of events being led by 197 voluntary leaders; the implementation of the 'ask Calvin' campaign on events – making it possible for members to ask for help when they need assistance; and the development of the subcommittees, showing fantastic results.

AGM/23/08 Sub-Committees Update

Emrys Williams from the Finance & Assurance Sub-Committee explained the group were reviewing policies & procedures and health & safety. They have now established who has what skills and will be able to implement a positive impact on the organisation.

Luke Mills from the Development Sub-Committee highlighted the growth opportunities now in place through the implementation of a sponsorship pack driving more partnerships and funding. The OutdoorLads bar has been utilised more also bringing extra funds back into the charity.

Lewis Garth from the Support Sub-Committee described how they have helped new members in the group attending events, and also in the training and development of new leaders and in getting them trained up as first aiders. From leafleting at Pride events, they also hope to grow the diversity of OutdoorLads.

And finally, Will Allaway from the Delivery Sub-Committee demonstrated how ongoing projects have helped benefit the charity, including cultural & heritage events and partnerships with other LGBTQ+ organisations.

They all asked members to get in touch if they want to get involved!

AGM/23/09 Remembering Friends

Joey Payne played a song for absent friends Anthony Pink, Duncan Farrow, Alex Neely & Mike Fulton and hoped members would remember the happy memories shared with them over the years.

AGM/23/10 Election Results

LR presented the election results as per item AGM/23/06 and confirmed the appointment of Peter Walter, Dave Lawrence, Neil Sharp and Jake Higgins as the new trustee board.

AGM/23/11 Overview of transitional Interim Board

Peter Walter discussed the arrangements, process and next steps. He acknowledged the concern that many questions relating to why the board were all stepping down had not been answered but re-iterated that they would be addressed after the meeting.

He said it was honest to say that two recent resignations on the board had made the current board come to their decision, but that shouldn't take anything away from all the hard work they had put in. He thanked them for their contribution and stressed members should be mindful and respectful in light of current events and appreciate their commitment and desire to help OutdoorLads be what it is today. He also thanked the staff for all their work behind the scenes.
